TERMS AND CONDITIONS AS DEEMED TO APPLY TO EXHIBITION ORDER

This agreement is made on the date as per overleaf "Exhibitor Contract" between the persons or company hereafter called "the Exhibitor" and the Aesthetics Practitioners Advisory Network Pty Ltd (APAN) hereafter called the "Organiser".

The Organiser agrees to promote the exhibition (APAN Aesthetics Conference) to person whom they want to participate in the said conference.

1. The physical area defined as the Exhibitor's stand will be a total area the Exhibitor will occupy, including any display items and the provided Trestle Table. If you require extra space please discuss this with the Organiser.
2. The Exhibitor shall not in any way obstruct the free movement of the delegates in walkways, entrances, service corridors or fire exists and shall not hinder the clear view of any of the other Exhibitors' stand front. If in the opinion of the Organisers such an obstruction or hindrance exists, the Organisers shall ask the Exhibitor to remove the obstruction immediately.
3. The Organisers will provide appropriate Public Liability insurance for the exhibition and stand area.
4. The Organisers accept no liability for damage to Exhibits by any cause whatsoever. Insurance of the goods is the responsibility of the Exhibitor and this insurance should cover the ingoing and outgoing periods as well as the operation days of the Exhibition.
5. All electrical work undertaken must be at the consent of the Organisers and the Hotel.
6. If the exhibitor wishes to make use of a microphone or any sound amplification they will need the prior approval of the Organisers.
7. In the unforeseen event or circumstance, which did render it necessary for the Organiser to alter the location of the stand space allocated to the Exhibitor, the Exhibitor accepts any re-allocation of space. The Organisers agree to, where possible, offer the second choice of similar value.
8. If in the unforeseen event of postponement, or amendment to the date for holding the event, the Organisers will not be liable for any loss occasioned.
9. The Exhibitor is responsible to see that all statutes, ordinances, or regulations are respected in all circumstances.
10. The Exhibitor agrees to pay the Organisers total monies as set down in the Exhibition Contact overleaf.
11. In the event of non-payment of any monies due, or in the event of any breach of any condition on the part of the Exhibitor, the Exhibitor will forfeit the right to occupy their allocated space and shall not be entitled to any refunds.
12. It is also understood by the Exhibitor that no refunds shall be made in the event of cancellation of the exhibition due to industrial action blackouts, fire or acts of God, or other causes beyond the control of the Organiser.
13. The Exhibitor agrees to use the allocated space at all times so as to ensure that the use and enjoyment of the other exhibitors and delegates is not prevented, interfered with, or adversely affected. We advise the use of pop-up banners be used as no items is permitted to be attached to the walls.
14. The Exhibitor hereby agrees to comply with the provisions of the Workplace Health and Safety Act at alltimes.
15. The Exhibitor hereby agrees that should they cancel their stand after the monies have been paid, they will not be entitled to a refund of the money, unless the Organisers can on-sell the stand to another party.
16. The Exhibitor hereby agrees to have their display on their stand and be in attendance between 8.30am to 5.00pm during the event.
